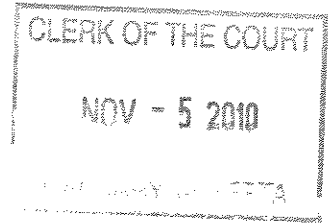

UPON the application of Alger & Associates Inc. (the "**Receiver**") in its capacity as Receiver and Manager of Alpine Quarries Inc. ("**Alpine**"); AND UPON hearing read the 2nd Report of Alger ("**2nd Report**"), filed; AND UPON being satisfied that no party shall be prejudiced by the granting of this Order;

IT IS HEREBY ORDERED THAT:

1. The Receiver's Statement of Receipts & Disbursements (as contained in Appendix 7 of the 2nd Report) is hereby approved.
2. The Receiver's Fees and Disbursements and the Receiver's Counsel's Fees and Disbursements (as contained in Appendix 8 of the 2nd Report) are hereby approved.
3. The Receiver's Final Account and the Receiver's Counsel's Final Account are hereby approved without further direction of this Honourable Court.

4. All steps taken by the Receiver in the Receivership of Alpine are hereby approved.
5. The Receiver is hereby authorized to destroy or otherwise dispose of the corporate records of Alpine if those records are not retrieved by any of the Directors of Alpine or Royal Bank of Canada, at their sole expense, on or before November 15, 2010.
6. All the remaining funds of Alpine, after payments of the Receiver's Final Account and the Receiver's Counsel's Final Account, shall be distributed to Royal Bank of Canada in ongoing satisfaction of the indebtedness of Alpine.
7. Alger is hereby forever and unconditionally discharged from any and all responsibilities and obligations as the Receiver of Alpine.
