**ORDER
(Sale Approval and Vesting Order)**

UPON THE APPLICATION of Alger & Associates Inc. ("Alger") in its capacity as Receiver of Alpine Quarries Inc. ("Alpine"); AND UPON HAVING read the First Report of Alger; AND UPON HAVING read the Supplemental Report of Alger; AND UPON HAVING heard counsel for Alger and all other interested parties;

IT IS HEREBY ORDERED AND DIRECTED THAT:

1. Service of this application is good and sufficient.
2. Time for service is abridged.
3. Sedock Holdings Ltd.'s ("Sedock") offer to purchase the Assets (as that term is defined in the "Invitation for Offers to Purchase the Assets of Alpine Quarries Inc.") of Alpine is hereby approved.
4. Alger, upon execution of a Bill of Sale, is authorized to take all such further steps and actions and execute all such other instruments and documents as is necessary to transfer and convey the Assets to Sedock.
5. Upon execution of a Bill of Sale, all of Alpine's right, title and interest to the Assets is vested in Sedock free and clear of all encumbrances, claims, security interests, security

notices, Statements of Claim, mortgages, liens (including, without limitation, statutory and builders' liens), and other interests, whatsoever, howsoever, and whensoever created or arising, whether absolute or contingent, fixed or floating, perfected or not, registered or unregistered, against Alpine's interest in the Assets.

6. Nothing in this Order shall vest title in respect of any of the assets, properties and interests of Alpine other than the Assets.
7. Except as to the vesting provided for in paragraph 5 hereof, all of the interest, right, title and estate of Alpine and any persons claiming by, through or under Alpine in and to the Assets is extinguished.
8. The proceeds of the Sedock Offer shall stand in the place and stead of the Assets.
9. Alger and Sedock are hereby authorized and given leave to apply to this Honourable Court for any Order that may be required or necessary to give effect to the terms of this Order or the Sedock offer to purchase the Assets.
10. This Order must be served only upon those interested parties attending or represented at the within application and service may be effected by facsimile, electronic mail, personal delivery or courier and, if served by facsimile or courier, service is deemed to be effected the next business day following the transmission or delivery of such documents.
11. Service of this Order on any party not attending this application is hereby dispensed with.

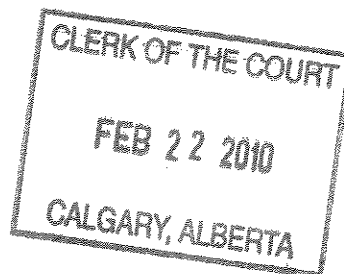
