**UPON THE APPLICATION** of the defendants, Aubrecht Holdings Inc., Petro Oilfield Services Inc., Petro Buyers Inc., N. Neufeld Oilfield Consulting Ltd., Windy Land Consulting Inc., Peter Aubrecht, Cheryl Aubrecht, Douglas Neufeld, Mary Neufeld, Janice Claros and Linda McMillan (collectively, the "**Applicants**"); **AND UPON** reading the Notice of Motion of the Applicants dated June 3, 2010; **AND UPON** reading the affidavit of Peter Aubrecht sworn June 3, 2010; **AND UPON** hearing submissions of counsel to the Applicants and counsel to any other parties who may be present; **IT IS HEREBY ORDERED THAT:**

1. The Plaintiff, Javelin Energy Inc. ("**Javelin**"), must answer the sixty-four (64) undertakings (the "**Undertakings**") given by its officer William Patterson during his February 25, 2009 cross-examination on Javelin's Affidavit of Records by no later than July 12, 2010;

2. If Javelin fails to provide answers to the Undertakings within the time stated in paragraph 1, above, then the Applicants have leave to reapply for an order that Javelin be held in civil contempt and the appropriate penalties be imposed pursuant to Rule 704;
3. Javelin shall post security for costs with the Clerk of the Court in the amount of \$72,712.50 to the credit of the Applicants, in Action No. 0801-05286 within 30 days of the service of this Order;
4. All further proceedings in Action No. 0801-05286 are hereby stayed until payment of the sum described in paragraph 3, above, is made in full;
5. If Javelin does not post security for costs as required by paragraph 3, above, this action shall be dismissed without further Order of this Court; and
6. Javelin shall forthwith pay the costs of this application.
