
AND UPON THE CONSENT of counsel for Janet Comte, the widow of David Comte;

IT IS HEREBY ORDERED THAT the Style of Cause in this Action be amended and that all further matters in the Action be intitulated:



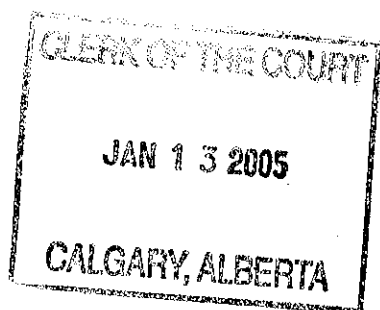
