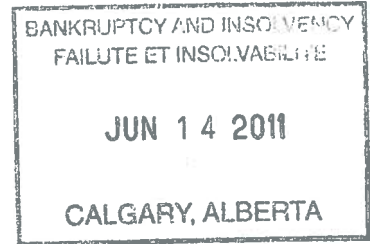

UPON THE APPLICATION OF Grant Thornton Alger Inc. And Upon Reading the Affidavit of Bruce E. Alger, to be filed herein; AND UPON BEING SATISFIED that the sale of the Calgary and Edmonton insolvency practice of Alger & Associates Inc. to Grant Thornton LLP has closed and that Grant Thornton LLP has incorporated Grant Thornton Alger Inc. which has been licensed by the Office of the Superintendent of Bankruptcy and that it is necessary and appropriate in the circumstances to remove Alger & Associates Inc. and appoint Grant Thornton Alger Inc. in its place as hereinafter set forth; AND UPON BEING ADVISED that the Superintendent of Bankruptcy does not object to this Order; AND UPON READING the Consent of Alger & Associates Inc.; hereon endorse;

IT IS ORDERED that Grant Thornton Alger Inc. be substituted in place of Alger & Associates Inc. as Trustee (or Administrator or, as applicable) of the files as listed in Exhibit "A" attached hereto hereinafter referred to as the "Subject Estates";

IT IS FURTHER ORDERED that the requirement for a separate Notice of Motion and supporting Affidavits to be filed in the Court file of each of the Subject Estates be waived;

IT IS FURTHER ORDERED that the requirement for notification of this application to proven creditors within the Subject Estates to the bankrupts and any other person other than the Superintendent of Bankruptcy is waived and service of a copy of the Order on any person other than the Superintendent of Bankruptcy is likewise dispensed with;

IT IS FURTHER ORDERED that Alger & Associates Inc. is authorized to transfer to Grant Thornton Alger Inc., all funds that remain in its consolidated trust bank accounts and all other trust bank accounts that belong to the estates and consumer proposals described herein. Once all such funds have been paid over, and possession of the estate files and records for the estates and consumer proposals herein described have been delivered to Grant Thornton Alger Inc., Alger & Associates Inc., shall be discharged with respect to such estates and consumer proposals and requirement for taxation of the accounts of Alger & Associates Inc. in respect of the Subject Estates. No further accounting by Alger & Associates Inc., shall be required for the purposes of Section 41 of the Bankruptcy and Insolvency Act;

IT IS FURTHER ORDERED that in its capacity as substituted Trustee or substituted Administrator, as the case may be, Grant Thornton Alger Inc. shall be and its hereby authorized to endorse for deposit, deposit, transfer, sign, accept or otherwise deal with all cheques, bank drafts, money orders, cash or other remittances received in relation to any of the estates or consumer proposals described herein where such cheques, bank drafts, money orders, cash or other remittances are made payable or delivered to Alger & Associates Inc., in relation to the same, and any bank, financial institution or other deposit-taking institution with which Grant Thornton Alger Inc. may deal is hereby authorized to rely on this Order for all purposes of this paragraph;

IT IS FURTHER ORDERED that the requirement and responsibility for taxation of the Trustee's (or Administrator's as the case may be) accounts in respect of the Subject Estates, from the date of bankruptcy, initial bankruptcy event date, or date of proposal having been filed, through to the completion of the administration and discharge of the new Trustee, is hereby assigned and transferred to Grant Thornton Alger Inc.;

IT IS FURTHER ORDERED that Grant Thornton Alger Inc. is now required to observe all the terms provided by Rule 61(2), keep all estate books, records and documents as provided by Rule 68, obtain from the former Trustee all books, estate records, documents including work in progress, billing or time records in support of any claims made for time charges and advances on fees made by the former Trustee, and detailed trial balances from the date of bankruptcy or proposal showing all the funds received and disbursed since the date of the bankruptcy, initial bankruptcy event or proposal, notwithstanding Grant Thornton Alger Inc. assuming responsibility for the Subject Estates as at the date of this order;

IT IS FURTHER ORDERED that the Registrar of the Land Titles Office is hereby authorized and directed to


amend any registrations previously made by Alger & Associates Inc. at the Land Titles Office, whether in its capacity as Trustee of a bankrupt estate, or as Trustee acting in a Proposal, or as Administrator under a Consumer Proposal, as the case may be, to reflect the substitution of Grant Thornton Alger Inc. for Alger & Associates Inc. as Trustee or Administrator, as the case may be, pursuant to this Order, upon the Registrar receiving a written request to make such amendment from Grant Thornton Alger Inc., which written request shall clearly describe the registration to be amended and the lands which are subject to such registration. Section 191 of the Alberta Land Titles Act shall not apply to any amendment made to a registration pursuant to this paragraph.

IT IS FURTHER ORDERED that the Original signed copy of this Order shall be filed in the estate of David Robert Landry and the Clerk of this Honourable Court is hereby authorized and directed to file a photocopy of this signed Order in any of the other estates or consumer proposals described herein, when and where required, and to provide certified copies of the same without the necessity of a further signed original of this Order.
