Further to our letter of January 3, 2005, we have not as yet received a response from you in relation to the information requests contained in that letter.

As you will recall from that letter, pursuant to the Interim Order of Justice LoVecchio made December 27, 2004, we act as Receiver for the captioned Limited Partnership (“Partnership”). The Order provides, amongst other things, that any present or former partner shall grant access to and deliver possession of records of every kind relating to the assets or operations of the Partnership. In that regard, a form for completion and remittance to us is attached to this letter. Please provide copies of all documentation related to the funds you provided to the Partnership and the funds paid to you by the Partnership.


